Ms. Sally Rich entertained a motion to start the meeting that is being recorded at 7:00 p.m. Dr. Fares Mouchantaf seconded. **Vote: All in Favor**

#### Minutes

<u>11-16-23 Minutes</u> – Dr. David Driscoll entertained a motion to approve the Board of Health meeting minutes from 11-16-2023. Dr. Fares Mouchantaf seconded. Ms. Sally Rich abstained due to not being present at this meeting.

<u>1/11/24 Minutes</u> – Ms. Sally Rich moved that the Board of Health accept the minutes of 1/11/2024 as written. Dr. David Driscoll seconded. Dr. Fares Mouchantaf abstained due to not being present at this meeting.

#### • Old Board of Health Business

92 Southern Avenue – Updates and Discussion 18 John Wise Avenue – Updates and Discussion 17 Kings Court – Updates and Discussion

Ms. Sally Rich asked Dr. Mouchantaf why the Board of Health condemns properties where people are not supposed to be living in but they continue to live at the properties for months and years. Ms. Rich asked if there isn't a way to remove people from the properties and lock the property up until repair work can be completed. Ms. Rich stated that if a property is condemned, then it's not supposed to be habitable. Dr. Mouchantaf

answered that it may be more of a question for the police, whereas the Board of Health imposes the order but the police should be enforcing the order. Ms. Rich asked why the Board of Health is not following up to find out why the police aren't doing the enforcement. Ms. Rich stated that she would like Ms. Erin Kirchner to look into that. Ms. Rich stated that it seems silly that the Board of Health votes to issue condemnation orders but nothing gets done. Ms. Rich stated that it's been a couple of years now that 17 King's Court was issued a condemnation order. Ms. Rich stated that she would like to see the Allen property (5&9 Southern Avenue) added to the old business section of the agenda because that property is coming up on the court docket again. Ms. Rich stated that she doesn't understand why we don't get any updates on that property. Dr. Mouchantaf stated that the Allen property has not been on the Board of Health agenda since he has been on the Board. Ms. Rich stated again that the Allen Property, 5 & 9 Southern Avenue, will be coming up on the court docket again soon. Dr. Mouchantaf asked what the upcoming court date is for. Ms. Rich answered that she thinks it is for non-payment of back taxes. Dr. Mouchantaf asked, once the Board of Health issues a condemnation order, who imposes it. Ms. Rich answered that the Board of Health can ask Ms. Kirchner to clarify that question. Ms. Rich also asked why the Board of Health isn't having a meeting with the Selectmen, the Building Inspector, the Fire Department, the Electrical Inspector, etc., since they are all involved in these condemnation orders. Dr. David Driscoll stated that the tools and resources that we have to enforce the orders that are issued are extremely limited in a town as small as Essex. Ms. Rich stated that the police should be able to enforce and have people escorted out of these properties because they had notice of the condemnation and they're not supposed to be there. Ms. Rich stated that locks should be placed on these properties and only contractors who have been issued permits to do work on these properties should be allowed inside. Ms. Rich stated that her feeling is that the Board shouldn't even condemn properties if they can't enforce the orders. Dr. Driscoll stated that the Board still has to condemn the properties that need to be condemned and because the Board has limited resources, Dr. Driscoll doesn't feel it's the Board's job to be policing the police. Ms. Sally Rich agreed. Ms. Rich again stated that she doesn't understand why the Board of Health isn't meeting with the other departments so that everyone is on the same page as to what is going on with the properties. Ms. Rich stated that in her opinion there should be more of an urgent nature to resolve these issues. Dr. Driscoll agreed. Ms. Rich stated that she thought there would be an agenda item for this meeting for a report about J's Junk Removal because she had asked at our previous Board of Health meeting about whether or not J's Junk is picking up recycling because she doesn't think his service is picking it up. Dr. Driscoll asked how the Board could prove that. Ms. Rich stated that Ms. Kirchner was going to check into it and that's why she expected to see a report, because not only by the Board of Health Regulation but by State Law, J's Junk is supposed to be providing recycling with the trash removal and she doesn't believe he is.

#### • Other Concerns, Issues & BOH Business

Ms. Rich asked about 64 Choate Street included on the Administrator's Report stating that the Title 5 inspector noted the dwelling has a garbage grinder and the system was not designed to accommodate this flow. Ms. Sally Rich questioned why the property has a garbage grinder when the Board of Health has sent Title 5 approval letters to home owners telling them that the system was not designed to accommodate the use of a garbage grinder. Dr. Driscoll stated that the Board only says that a system has not been approved for use of a garbage grinder but that the Board can't enforce this.

Ms. Sally Rich stated that she doesn't understand what is happening with the property of 18 John Wise Ave. because the home owners were supposed to have their septic system pumped by the 18<sup>th</sup> of January and supply the pump slip to the Board of Health office but on January 19<sup>th</sup> they had not supplied the pump slip to the Board of Health office. Ms. Rich stated that Ms. Kirchner informed her that the Department of Environmental Protection (DEP) gives 30 days. Ms. Rich stated that we are now past the 30 days and they haven't supplied a pump slip, nor have the homeowners supplied contractor information for connection to municipal sewer which the homeowner said would be done in two to three weeks but there is nothing going on. Ms. Rich stated that Ms. Kirchner informed the Board that legal counsel has advised that the property owners can take advantage of the 2% Low Interest Loan to help with sewer connection and that Ms. Kirchner has advised the property owners that they can take advantage of this loan but the owners are currently in violation. Dr. Driscoll stated that his understanding is that the property owners are in progress of trying to become compliant. Ms. Rich stated that the home owners are saying that, but they aren't supplying any information to Ms. Kirchner. Dr. Driscoll stated that Ms. Kirchner isn't present to address where the homeowner's are with the project but that it is being addressed and it is in progress, we just don't have that information.

Dr. Driscoll asked if there were any other complaints or updates. Ms. Sally Rich stated that the property at 21 Main Street has been ongoing since 1/15 and there was supposed to be an extermination of rodents in that apartment but there is nothing definitive stating whether an extermination was done or not after over a month.

Dr. Mouchantaf seconded. Vote: All in Favor.






