Members Present: Chairman Ben Buttrick, Rob Fitzgibbon, Allison Williard, Guy Bradford, Michael Flynn, and Michael Antell.

Chairman Buttrick called the meeting to order at 7:04 p.m., motion made, seconded and unanimously approved.

Chairman Buttrick discussed a couple of ideas to postpone funding parts of the overall general fund budget given the current market environment conditions of the town. The Library Department agreed to hold funding for the new part time position of 19 hours in the amount of \$20,441., and the Youth Department agreed to withdraw funding for the Youth Department, in the amount of \$39,605., pending the Fall Town Meeting.

Treasurer Soulard discussed market conditions and the inability to fund the Public Safety Building Bond because of rapidly declining conditions. Treasurer Soulard discussed the unsettled short term market and what our run rate will be on the Public Safety Building costs to 6/30/2020. Treasurer and Financial Advisor feel that short term financing will stabilize and we will know more by the Fall Town Meeting.

Town Administrator Zubricki discussed the date change to Annual Town Meeting of 6/15/2020. Finance Committee, Board of Selectmen, along with Town Administrator Zubricki discussed the Annual Town Meeting Warrant.

Chairman Buttrick made a motion to approved amended FY21 Budget, motion made, seconded and unanimously approved.

A motion was made, seconded and unanimously voted to approve a line item transfer for \$1,000.00 to cover costs of Harbormaster Salary.

A motion was made, seconded and unanimously voted to adjourn at 8:09 pm.
