E. Building Permit Applications & Occupancy Permits

I received and reviewed a building permit application for this property (the old TD North Bank), for interior renovations only. The property is on public sewer. These renovations included the removal of approx. 400 sq. ft. of floor tiles that tested positive for asbestos. Notification of the asbestos removal has been given to DEP and us.

Because the renovations are cosmetic only, and with Board permission, I signed off the BP application.

Recommendation: Retroactive permission to approve the application for "interior renovation, including some wall relocation and all interior finishes". This application is dated 3-26-14.

(1) Wood Drive

We received a complaint of a sewage outbreak on a public way on Wood Dr. I originally inspected some time ago, but found no surface water at the time. I went back on 4-2 and sampled. A surface runoff sample resulted in 5800 e. coli/ml and a sample taken from under a makeshift cover tested at 3300. Most of the properties in the area have relatively new septic systems, so the investigation may take some time.
