This most recent plan will supersede the plan that was approved on May 31, 2016 for a 6-bedroom residential dwelling. While the septic system has an excess design flow of 460 gallons per day, any proposed additional flow will need to be approved by both the Board of Health and the Building Inspector prior to construction or connection.
