Minutes

Dr. Mouchantaf made a motion for the Board to approve the minutes, as written, for June 24, 2021. Dr. Driscoll seconded the motion. **Vote: All in Favor.**

Ms. Rich made a motion for the Board to approve the minutes, as written, for September 9, 2021. Dr. Driscoll seconded the motion. **Vote: All in Favor.**

• Bills Payable

Dr. Driscoll entertained a motion for the Board to retroactively approval bills payable #679, in the amount of \$4,924.78. Ms. Rich so moved. **Vote:** All in Favor.

Dr. Driscoll entertained a motion for the Board to approve bills payable #680 in the amount of \$1,592.53. Ms. Rich so moved. **Vote: All in Favor.**

• Title 5 Inspection Reports

The Board agreed to continue the issue of the failed septic system pending results from a new Title 5 inspection of the system serving 5 Cogswell Road, Map 110, Lot 28. The new Title 5 must be conducted no later than 11/24/21.

Dr. Driscoll made a motion for the Board to sign and send a letter to Bona, 47A Choate Street, Map 105, Lot 12.1, stating that the Board is in agreement with the determination of inspector Michael Fisher that the system passed the official Title 5 inspection conducted on August 17, 2021. This system is designed to accommodate no more than 2 bedrooms. Ms. Rich so moved. **Vote:** All in Favor.

Dr. Driscoll entertained a motion for the Board to sign and send a letter to McPherson, 37 Wood Drive, Map 154, Lot 29, stating that the Board is in agreement with the determination of inspector Daniel Ottenheimer, that the system passed the official Title 5 inspection conducted on September 9, 2021. However, the inspector noted that the dwelling has a water treatment unit that discharges into the septic system. Water softeners and other chemicals should not be

discharged to an on-site wastewater system. The existing system is designed to accommodate no more than 2 bedrooms. Ms. Rich so moved. **Vote: All in Favor.**

Dr. Driscoll entertained a motion for the Board to sign and send a letter to Bediz, 85 Conomo Point Road, Map 110, Lot 59, stating that the Board is in agreement with the determination of inspection Jon Granz, that the two bedroom tight tank passed the official Title 5 inspection conducted on September 7, 2021. However, no pumping contract was included with the Title 5 inspection, a requirement for all holding tanks. The property owner shall submit a pumping contract no later than November 1, 2021. Ms. Rich so moved. **Vote: All in Favor.**

Dr. Driscoll entertained a motion for the Board to approve Mr. McPherson's requested variance to allow a well to be shared among two or more dwellings on the property at 194 Southern Avenue, Map 209, Lot 1, for as long as the property is held by one owner. If ownership transfers to separate owners, the proposed three houses would each need a separate well. Dr. Mouchantaf so moved. **Vote: All in Favor.**
