Discussion: Ms. Rachel Lee, Regional Public Health Nurse, and Ms. Jessie Palm, Regional
Social Worker presented information provided by the Massachusetts Department of Public
Health regarding the recently-announced nationwide opioid settlement. Ms. Kirchner explained
that all communities in the Commonwealth have received notification of funding available from
this settlement, including the 4 communities in the Eastern Essex Public Health Excellence
Coalition: Essex, Hamilton, Rockport, and Wenham. The amount of funding varies depending
on population and historical impact of the opioid crisis; Essex will be receiving approximately
\$24K over the next 10 years. Ms. Lee suggested that the 4 communities in our Coalition discuss
pooling resources in order to best utilize available funding within state guidelines, since
allowable expenses are limited to services targeting harm reduction. The Board members will
review the materials given and follow up at a future meeting
