I hereby certify that the following action was taken at the Annual Town Meeting of March 5, 1883:

Article 19

Voted on Report of D.W. Bartlett to name the streets as follows:

- From Joshuas Corner to Manchester line Southern Avenue
- From Joshuas Cor. to Gloucester line Eastern avenue
- That the road from Eastern Avenue to Miles S. Andrews be Grove Street
- That the road from Eastern Avenue at Willard Smiths to Conomo Point be called Lufkin Street
- That the road from Eastern Avenue to Town Farm be called Conomo Street.
- The road from Southern Avenue to Grove St. be called School Street
- The road from Southern Ave by Ceder Mile and round to Southern Ave. again be called Cogswell Street
- The road from Southern Ave. to John Jenkins be called Forest Street.
- The road from Southern Ave., to Manchester line by old Road be called Andrews Street.
- The road from Southern Ave., to Iac. Andrews Estate be King Street
- The road from Joshua's Corner to Perkins Corner be called Main Street.
- The road from Perkins Corner over Foster's Hill to the Hamilton line be called Western Ave
- From Perkins Corner to Ipswich line be called Northern Ave.
- From Northern Avenue to Hog Island be Island Street
- From Main Street near Richardson Hall to Western Avenue at the Falls Martin Street
- From Martin Street to Western Avenue near residence of E--- Perkins Pickering Street
- From Martin Street to Western Avenue at Fosters Bridge Winthrop St
- From Main Street to Boyds Farm be Spring Street
- From Main Street to Widow Nathan Burnhams be Burnham Court
- From Western Avenue at the Falls to Warren Lows corner be called Apple Street
- From Western At Tan Yard to Mrs. Poland be called Pond Street
- From Fosters Bridge round by old road to Western Avenue be called Story Street
- From Northern Avenue at Dodge Hill to Ipswich line be called Choate Street
- From Story Street to Choate Street be called Belcher Street
- From Eastern Avenue to Clay Point be called River Street.
