

#### Nine Goals for Essex



- Renew and finance critical Town infrastructure by building a new public safety facility, replacing the Memorial School in Manchester and renovating the Essex Elementary School, replacing old water system components and maintaining the Town's ten-year-old sewer system;
- 2) Increase participation in Town government;
- 3) Maintain and develop a strong business community;
- 4) Increase the amount of protected land in Essex;
- 5) Improve the health of and access to Essex's rivers and lakes;
- 6) Expand the range of recreational opportunities and assets, particularly for young people;
- 7) Develop and deliver a fiscally responsible school budget consistent with multi-year forecasts;
- 8) Maintain the viability of the Town's call Fire Service; and
- 9) Meet the housing needs of all Essex residents.



- Develop a plan for building/rebuilding the Town's public safety facility(ies), including the means of financing such improvements.
- Develop a school reconstruction plan with Manchester, including financing, for renovating the Essex elementary school and replacing the Manchester elementary school.
- Develop plan to replace (and finance) 18-20 miles of old water mains and remove asbestos cement mains, as well as address other long-term water and sewer system needs, such as filtration.
- Examine opportunities to dispose of surplus town properties.


#### 2) Increase Participation in Town Government



- Conduct public awareness activities to inform residents of major government events and ways they can get involved.
- Develop an Essex 101 guide to town government.
- Inspire participation by considering fun ways to get residents involved
- Explore possibility for hosting voter information nights that also serve as community building events.
- Town Boards and Commissions should develop outreach plans for engaging residents, recruiting new members and mentoring them
- Consider alternatives to existing town voting/elections (e.g. Saturday town meeting, babysitting, pairing with national elections in November).

Percentage off due to rounding


## 3) Main and Develop a Strong Business Community



- Support initiatives at the Select Board level creating a fertile field for new ideas, concepts and ventures.
- Establish a Zoning Sub-Committee of the Essex Planning Board to look how zoning can support economic development and create new zone(s).
- Adopt a Downtown Overlay district to ensure clearer ground rules for development and to address the needs of non-conforming lots.
- Conduct economic development review to determine locations for new commercial development and attract businesses.
- Consider whether renewable energy generation can support economic development.
- Aid businesses outgrowing home occupations and incubate more local businesses.
- Win grants to spur improvements in decorative parking, street lighting and other aesthetic improvements, town land realignment and boardwalk construction.
- Sponsor Town events that draw people to Essex businesses.

#### 4) Increase the Amount of Protected Land in Essex







- Use future/additional CPA funds to support conservation priorities and leverage additional private resource for land protection.
- Identify land parcels of greatest environmental and scenic value for protection.
- Develop stronger relationships with local conservation groups, such as Essex County Greenbelt and the Manchester-Essex Community Trust to engage land owners and identify financing for permanent preservation.
- Adopt appropriate zoning to protect essential parcels of land consider a Conservation By-Law.
- Develop an inventory of protected lands that can be accessed publicly.
- Better understand what contributes to protecting scenic view sheds.

### 5) Improve the Health of/Access to Rivers and Lakes



- Develop long-term dredging plans for the Essex River.
- Work with local groups (e.g. Great Marsh Coalition and Ipswich River Watershed Assoc), to measure and monitor pollution/runoff levels.
- Consider guidelines to help residents remove/contain invasives, e.g. phragmites.
- Work with the state to pursue measures to reduce green crab populations.
- Implement public access improvements to Conomo Point and complete long-term leases to finance improvements.
- Finalize the Resource Management Plan for the Areas of Critical Environmental Concern and continue to analyze and plan for sea-level rise and coastal storms.
- Review policies used in other communities to regulate water pollution.
- Work with Hamilton to better manage/enforce rules on Chebacco Lake.
- Consider steps to increase shellfish populations (e.g. harvest limits, Sunday closures, reclassifying flats).


#### 6) Expand the Range of Recreational Opportunities



- Use future/additional Community Preservation Act funds to support recreational priorities.
- Examine whether an Essex Youth Commission should be reestablished by creating an exploratory committee, which should examine interest and consider whether a part-time director can be hired, and a partnership with Manchester developed.
- Assess the current stock of recreational facilities to quantify existing maintenance costs and capacity for additional facility and grounds.
- Build maintenance costs for any new or refurbished recreational facilities into capital plan.
- Consider Memorial Park improvements, such as the feasibility and support for new tennis courts.
- Use zoning to preserve recreational resources.

### 7) Deliver a Fiscally Responsible School Budget





The Town spends appx. 52% of its annual operating budget on education (not factoring in capital funds, otherwise the percentage is 39%)

## 7) Deliver a Fiscally Responsible School Budget



- Monitor budget through an informal group of school district and municipal officials from both Manchester and Essex.
- Maintain multi-year budget forecasts and plans to enable member towns to anticipate school needs.
- Ensure a settled three-year contract with the Manchester-Essex Teachers Association that aligns with multi-year budget projections.

## 8) Maintain the Viability of the Town's Fire Service



- Recruit new volunteer on-call firefighters.
- Support the Fire Explorers program to develop future candidates for the fire service.
- Consider whether the Department would benefit from full-time leadership in the future.
- Ensure all firefighters receive required training.
- Examine ways to ensure inspections are carried out in a timely manner.

## 9) Meet the Housing Needs of all Essex Residents



- Adopt a Mixed-Use Zoning By-Law (2<sup>nd</sup> floor residential over commercial) to enable better utilization of already developed land.
- Allow "in-law" apartments (through zoning change).
- Examine affordable housing needs of current Essex residents.
- Determine how best to support housing using CPA funds.
- Consider partnering with neighboring communities on a joint housing plan
- Conduct a market analysis for the Town.
- Apply for grant funding for housing studies.
- Explore ways to reduce costs for homeowners, including energy cost savings through MassSave free home energy audits.



• The SPC will remain constituted to help steer implementation

• Priorities will be set for the short and long-term, based on affordability and need

• The Plan will be a living document, updated to reflect changing priorities and conditions

• Town resident involvement will be vital for the Plan to be realized
