Below is the Strategic Planning Committee May 2019 quarterly report for the Town's Strategic Plan. This report tracks the progress in the implementation of the plan. This is a quarterly report covering through May 15, 2019.

#### **BACKGROUND**

In 2016 the Strategic Planning Committee (SPC) worked to finalize the Town's strategic plan by prioritizing goals and developing a system to track the Town's progress in implementing the plan. Going forward, the SPC will work with Town departments and boards and committees to ensure that Town initiatives adhere to the goals of the Town's Strategic Plan. This is the most recent quarterly report on the progress in implementing the plan.

The Strategic Planning Committee was created by the Board of Selectmen in the spring of 2015 to develop a Strategic Plan for the Town. Its membership consists of representatives from other existing boards and commissions, including the Planning Board, School Committee, Finance Committee, Conservation Commission, Public Works Committee, Council on Aging, Community Preservation Commission, and the Conomo Point Planning Committee. The SPC drew on previous town planning efforts, including the *Planning to Preserve the Best of Essex* report produced by the Long Term Planning Committee in June of 2015. Through a series of seven, two hour workshops, the SPC created a strategic plan that included nine goals for the Town to pursue (link to draft plan). The plan was made available for public comment in December of 2015. In addition, the SPC hosted a Public Forum on February 10, 2016 to present the plan and take comment. A video recording of the forum is available on the SPC webpage.

The Strategic Planning Committee is grateful for all the public feedback received from the first draft of the plan. The SPC relied heavily on public feedback in setting priority goals for the implementation of the Strategic Plan. The two main themes from the feedback were:

- There are not enough Town funds to pursue all of the goals outlined by the SPC, and thus the SPC should prioritize the goals of the plan based on what is most important and essential to the Town in the future (e.g. needs before wants).
- The public needs to have ample opportunities throughout the strategic planning process to vote, approve and fund any action and initiative that is generated from the strategic planning process, and the SPC should work on ways to better inform the public.

Based on this feedback the Committee set priority goals for the Town. The two highest priority goals (Priority 1) are

- Renew and Finance Critical Town Infrastructure
- Maintain and Develop a Strong Business Community.

The next set of goals (2<sup>nd</sup> priority) would be

- Increase participation in Town government
- Improve the health of and access to the Essex River and Chebacco Lake.

The remaining goals (Priority 3) would be the lowest priority.

Identifying highest priority goals ensures that these are the focus for the Town. The SPC recognizes that the Town may work towards goals of different priorities simultaneously but advises the Town to consider how pursuing other goals will affect achieving the priority goals in terms of the dedication of resources.

Working towards the nine goals of the Strategic Plan will be incremental. This document will serve as a quarterly report and will be maintained by the Staff Planner for the SPC to track the progress of each project or initiative. Within each priority is a gray box: When an item is completed it would be recorded in the gray box in each priority section, and another project or initiative from the Strategic Plan list of actions would be added to this list for the Town to work on. Also, it is possible that the SPC will soon at a tenth goal - "Building Coastal Resilience", since it appears from work conducted recently that much attention will be required to keep the Town in good stead with the predicted effects of sea level rise and climate change.

#### **PRIORITY 1** — Current Actions

- Public Safety Building A proposal to purchase the Village Restaurant property for a new fire station was brought to Town Meeting in May of 2018 but did not receive the necessary % vote needed to authorize the purchase of the property. A Project Manager has been hired to re-assess the Town's options, using funding approved at a Special Town Meeting in August of 2018. The Town and Building Committee has been assisted by the Project Manager and an architectural firm, Johnson Roberts Associates (JRA), to continue to work on options at the current Fire Station site, an adjacent site in Memorial Park, and the Town property that abuts John Wise Avenue from the Spring Street Cemetery. JRA was hired using funding approved by Town Meeting in the fall of 2018. The Selectmen solicited offers from private property owners to sell property to the Town for a public safety building site and no qualifying offers were received at first. Later, the owner of 11 John Wise Avenue, which abuts the Town cemetery property, agreed to sell that property to the Town. The Committee's goal was to propose a final solution to the Annual Town Meeting in May of 2019 and has done so. That solution ended up being a combined facility on the combined John Wise Avenue site, as opposed to the other options studied. The Town Meeting has funded the design through project bidding and award and the Annual Town Election in May of 2019 approved the necessary debt exclusion. In the fall of 2019, a final Town Meeting will vote on approving borrowing and appropriating funds for the actual construction project. .
- Water System Infrastructure The Annual Town Meeting in May of 2018 appropriated \$50,000 for a comprehensive study of the Town's entire water system, in order to prioritize which elements will need to be addressed first, what the overall timeline will be, and what the cost of upgrades and line replacements is expected to be over the long term. That study is being undertaken by Wright-Pierce and the preliminary report has been issued. The Board of Public Works is reviewing the report and may have recommendations for funding the first phase of system upgrades in the fall of 2019.
- Memorial Park Plan and Public Safety Building At the recommendation of the Town Building Committee, the Board of Selectmen proposed to the Fall Town Meeting non-CPA funding to complement existing CPA funding for Memorial Park Plan. This new funding was used to investigate alternative building footprint and roadway layout options for a future replacement of the police/fire HQ in the area of 24-30 Martin. As noted above, the Town Building Committee has recommended another site for the proposed public safety building and the Memorial Park Plan may be picked up again if and when the current public safety is prepared for demolition. . Also, a private group of residents has expressed interest in raising funds to improve the main baseball diamond, including better accommodations for spectators.

- Green Communities In February of 2019, the Town completed Green Communities projects at Essex Elementary School, the second phase of LED interior lighting upgrades and the expansion of capabilities for the building's energy management system. The projects had a combined cost \$155,000 and were covered entirely by a Green Communities grant. In March of 2019, the Town applied for \$29,000 to fund the conversion of all public street lights from the old-style lamps to new, LED lamps. A second grant program offered by MAPC will be used to complement the Green Community grant in this area.
- Memorial Elementary School The Manchester Memorial Elementary School Feasibility Study concluded with a recommendation for a final campus and building configuration. Both Towns voted on October 16, 2018 and November 6, 2018 to approve the costs of final design, construction, and construction oversight, via a debt exclusion. Construction will begin in the summer of 2019, after school gets out for the year.
- Essex Elementary School The Town was awarded a Green Communities grant for additional LED lighting and upgrades to the building's energy management system. As noted above, those projects have been completed.
- LED Streetlight Conversion The Town Administrator and Town Planner worked with the Board of Selectmen on different options for converting the Town's 115 streetlights to LED fixtures. The conversion will reduce electricity consumption to lower utility bills and will relieve the Town from having to pay costly monthly fixture rental fees to National Grid, as well as improve lighting quality. Town Meeting has set up and has begun to fund a future maintenance account, since National Grid will no longer maintain the system. The Town plans on funding the project partially through a grant program managed by the Metropolitan Area Planning Council (MAPC) Rapid LED Program, which covers 30%. The remainder of the project would be funded through a Green Communities Competitive grant. Essex is participating in the MAPC program and applied for a Green Communities grant in March of 2019. The Town has already purchased the fixtures on the poles from National Grid, a prerequisite to conversion to LED.

- Economic Development Plan The Town was awarded a District Local Technical Assistance
  (DLTA) grant through the Metropolitan Area Planning Council (MAPC) for an Essex Economic
  Development Plan that will provide the opportunity to engage the newly formed Committee
  and the general public to identify programs, policies, and strategies that can help local
  businesses and attract new economic opportunities. All work will proceed under the purview
  of the Economic Development Committee (EDC). The project should begin in June and last for
  9 months.
- Economic Development Committee The EDC had their official first meeting in March of 2018
  at a joint meeting with the Strategic Planning Committee and has tried to meet on a monthly
  basis thus far. Current projects include the implementation of the Village Center Parking
  Strategy, the Economic Development Plan mentioned above, and the Main Street parking

- project that would design and install improved pavement marking and wayfinding signage in the downtown area (see below).
- Essex Parking Study Next Steps At Town Meeting in May of 2019, \$84,000 in funding was appropriated to implement the marking of parking spaces and addition of wayfinding signage on Main Street recommended in the 2016 Parking Study. The Town will be working with Stantec on permitting through MassDOT and construction bid documents.
- **Zoning** The Village Center Zoning Study has been completed and is now on the <u>Town</u> <u>website</u>. The Planning Board will take up the study's recommendations over the coming months, with an eye toward a possible zoning proposal to Fall Town Meeting.

- 575 votes were cast in the May 13, 2019 Annual Town Election. This is 21% or eligible voters (2,737 total).
- 2,026 residents voted in the November 6, 2018 Special Town Election. This is 72.6% of eligible voters (2,792 total) and 40% greater than the 2018 Annual Town Election.
- 798 residents voted in the May 14, 2018 Town Election. This is 32% of eligible voters (2,514 total) and 2% less than 2017 Town Election.
- 570 residents participated in the Annual Town Meeting on May 7, 2018. This is 23% of eligible voters (2,514 total).

• Climate Change and Essex River - The Town continues to engage various parties in our ongoing climate change work. A Community Compact in this area is already done. The Army Corps of Engineers committed to a full feasibility study that will compare the cost and benefit of traditional dredge spoil disposal to possibly using spoils within the Essex River System to restore environmental quality and perhaps make the marsh the Town's best "green" infrastructure for future coastal resiliency. The study may take up to two years to complete but we are hopeful that our state of readiness will translate to climate change and sea level rise mitigation funding that may be offered by the Federal government in the future. The Corps will also review the prospect of traditional maintenance dredging with sea or land spoil disposal, on a parallel track to its beneficial reuse study. The Town successfully became a

Municipal Vulnerability Preparedness (MVP) Community, which afforded the Town extra credit on two MVP Action Grants which are ongoing. The MVP program is administered by the Massachusetts Executive Office of Energy and Environmental Affairs (EOEEA). The Town applied for two additional MVP grants in April of 2019 and is awaiting word on funding status. Further, the Town will be applying in June of 2019 for State grant funding for the replacement of the Conomo Point seawall system.

- Municipal Vulnerability and Climate Change: The Town was awarded a grant from the Executive Office of Environmental Affairs that was applied towards a process that helped the Town achieve the Municipality Vulnerability Preparedness (MVP) designation from the state. The Town also was awarded and has completed the scope of a grant from the Massachusetts Office of Coastal Zone Management (CZM) to get the public more familiar with coastal resiliency via showing how this field goes hand in hand with emergency planning. The town has been awarded two MVP Action Grants: one grant will begin to study the feasibility of using mussel reefs to stabilize the salt marsh horizontally and the other grant will work in Essex, Ipswich, and Newbury is presently evaluating how the salt marsh recovers from a significant natural sediment deposition event that occurred in January of 2018. The Town was also awarded a grant to develop a comprehensive design for the future improvement and renovation of the Conomo Point Seawall system.
- MVP Grant and Climate Change: The Town was awarded a second grant from Coastal Zone
  Management (CZM) to get the public more familiar with coastal resiliency via showing how
  this field goes hand in hand with emergency planning. The grant work has been completed.
- Congress has approved official changes to the Federal Channel boundaries in the Essex River, which will has made the channel free of encroachments and, consequently, eligible for Federal dredging or other funds. Simultaneously, efforts to understand the implications of climate change and sea level rise are turning to the initial implementation of strategies to mitigate those future effects. As noted above, the Town has worked closely with the Army Corps of Engineers, Mass CZM, and Mass DEP to request a feasibility study that would consider the re-use of dredged materials within the Essex Bay system, thereby solving the navigation problem and making progress toward a more resilient coastal environment.
- Hazard Mitigation Plan Update The Town is working on updating its Hazard Mitigation Plan from 2012 using a grant secured through the Metropolitan Area Planning Council. The Plan needs to be updated every five years in order to remain eligible for Federal hazard mitigation grants. Various public input sessions have occurred and that work should wrap up in June of 2019.
- ACEC Resource Management Plan Project The Town Administrator explored with Gloucester, Ipswich, Rowley, and Newbury the prospect of a Resource Management Plan for the Great Marsh Area of Critical Environmental Concern (ACEC). A summit involving many stakeholders was held on September 20, 2017 in the newly-renovated Town Hall. For more information on the ACEC use this link. The group agreed to possibly use a new CZM Coastal Resiliency grant and the soon-to-be-released Great Marsh Adaptation Plan as the nucleus for a potential Regional Management Plan in the future.

- Open Space Plan The Open Space Committee released a survey for residents to fill out that will help the Town prioritize action items included in the 2015 Open Space Plan. The Town Planner will continue to work with the Committee to get the revised Plan fully accepted by the State.
- **Develop Stronger Relationships with Local Conservation Groups** MECT collaboration with SPC/ Open Space Committee
- Increase Protected Land in Essex The Town coordinated with Essex Greenbelt and neighboring Towns on the acquisition and creation of the Sagamore Hill reservation. The Town approved CPA funds to help with the acquisition.

- Essex Youth Commission The Board of Selectmen has rejuvenated the Essex Youth Commission with five new members The Commission created a revised position description for a Youth Director and the new Director was hired in April of 2018. The Commission is working with the Director to develop new programs for the youth of Essex.
- Centennial Grove Master Plan The Annual Town Meeting approved funding for a Master Plan for the future management of and amenities at the Centennial Grove. The Selectmen have worked with the Finance Committee to release a Request for Proposals for a cost-driven Master Plan. Proposals were due on October 19, 2017. Unfortunately the Town did not receive any proposals. The Selectmen are working with the Youth Commission to determine whether, together with the YMCA, more programs and amenities can be offered to Town residents at low or no cost. Town Meeting did provide some funding to clean out the facilities at the Grove and to make them safe for use by youth and other programs. This work is almost complete.

 Affordable Housing - The Town Planner submitted a successful application for the Municipal Engagement Community program through the Citizens' Housing and Planning Association (CHAPA). The program provides free technical assistance to communities pursuing housing production and affordable housing. The Town has assembled an Essex Housing Coalition

Group and held two meetings since December 2018, with the third meeting to occur in June. CHAPA staff has also been meeting with key stakeholders and attended other community meetings, and will work with the Coalition to conduct public education efforts in support of housing production, with an emphasis on affordable housing. Strategies and an implementation plan will be developed.

- **Technical Assistance** SPC worked with Planner and Town Administrator to identify an expert who could analyze what a Community Compact for housing means in Essex and how this could get us out of first gear (see CHAPA, above)..
- Learning from and partnering with Manchester Town Planner recommends that the SPC invite the Town Planner from Manchester or a member of their affordable housing organization to present on their process and successes in creating an affordable housing policy. CPC could be invited to this presentation as well since CPA funding could be used towards affordable housing. The Essex Housing Authority could also be involved. Manchester has expressed interest in partnering with Essex on a regional housing strategy.
