

### INTRODUCTION

This Plan has been developed through a series of public Strategic Planning Committee (SPC) meetings, reviewing recent accomplishments and updating the Town's long-term priorities. The SPC is comprised of representatives from:

- Board of Selectmen
- Finance Committee
- Planning Board
- Conservation Commission
- Historical Commission
- Economic Development Committee
- Representatives from key stakeholder groups
- Town Administrator
- Town Planner

The SPC has developed ten goals, each underpinned by a set of actions to achieve those goals. These ten goals address a broad range of topic areas, from town facilities and public safety, to land conservation and school budgets. While the goals do not address every matter confronting the Town, we believe the Plan addresses the most pressing challenges currently facing Essex.
